We gladly accept your application for employment at this time.

To work at MET you are required to possess a Class B Commercial Driver License (CDL) with air brakes and passenger endorsement. **If you have a Class A, you will still need the passenger endorsement.** If you do not already have a Class B CDL but would like to be considered for employment, you are required to possess or obtain a CDL permit. This means that you will have to complete three (3) written tests at the Iowa Department of Transportation (DOT) and obtain a <u>Commercial Driver License (CDL) permit.</u> This is required to **be hired by MET and** begin classroom training

The three knowledge tests that you need to pass are:

- The general knowledge test, taken by all applicants
- The passenger transport test, taken by all bus driver applicants
- The air brakes test, which you must take if any of the vehicles you will drive, has air brakes.

If you are hired and begin in the classroom, MET will provide the training and vehicle needed in order to complete the remaining tests to get your CDL.

If you have a Class A CDL and need the passenger endorsement, you will also have to complete the written passenger transport test and you will be required to take the skills tests at the DOT again. The skills tests would be done once you begin training.

You can get a CDL Driver's License Manual from the DOT driver's license stations or find it online at www.iowadot.gov. You will need to read and study sections 1 through 5 in order to prepare for the tests to get your CDL permit.

Please let us know when you have your permit so we can set up an interview. Applications will be kept on file for a period of one year. <u>You will not be eligible to start training unless you have a Commercial Driver</u> <u>License (CDL) permit.</u>
